Storage Condition:

At the time of our attendance at the factory, we found the fenders were placed in the manufacturer's open yard, in normal condition.

Packing:

The Fenders were in nude packing, with the chains and used tires around the fenders' body.

The marking was printed on the body of fenders, details as below:

Size checking:

According to client's requirement, total 5pcs of fenders were measured sizes, including the overall length and overall diameter, details as below:

1. The measurement tools were provided by the factory without the calibration certificate, and the measurement was done approximately as shown in pictures here under. The result was for reference only.

2. The measurement was checked at inflated 50kpa pressure.

Air tightness test to check for leakage:

According to client's requirement, the above mentioned 5 pieces of fenders were charged at pressure declared by UD. 50KPa under BV inspector witness, then covered with the soap water on the surface of the fender to check the air lea




